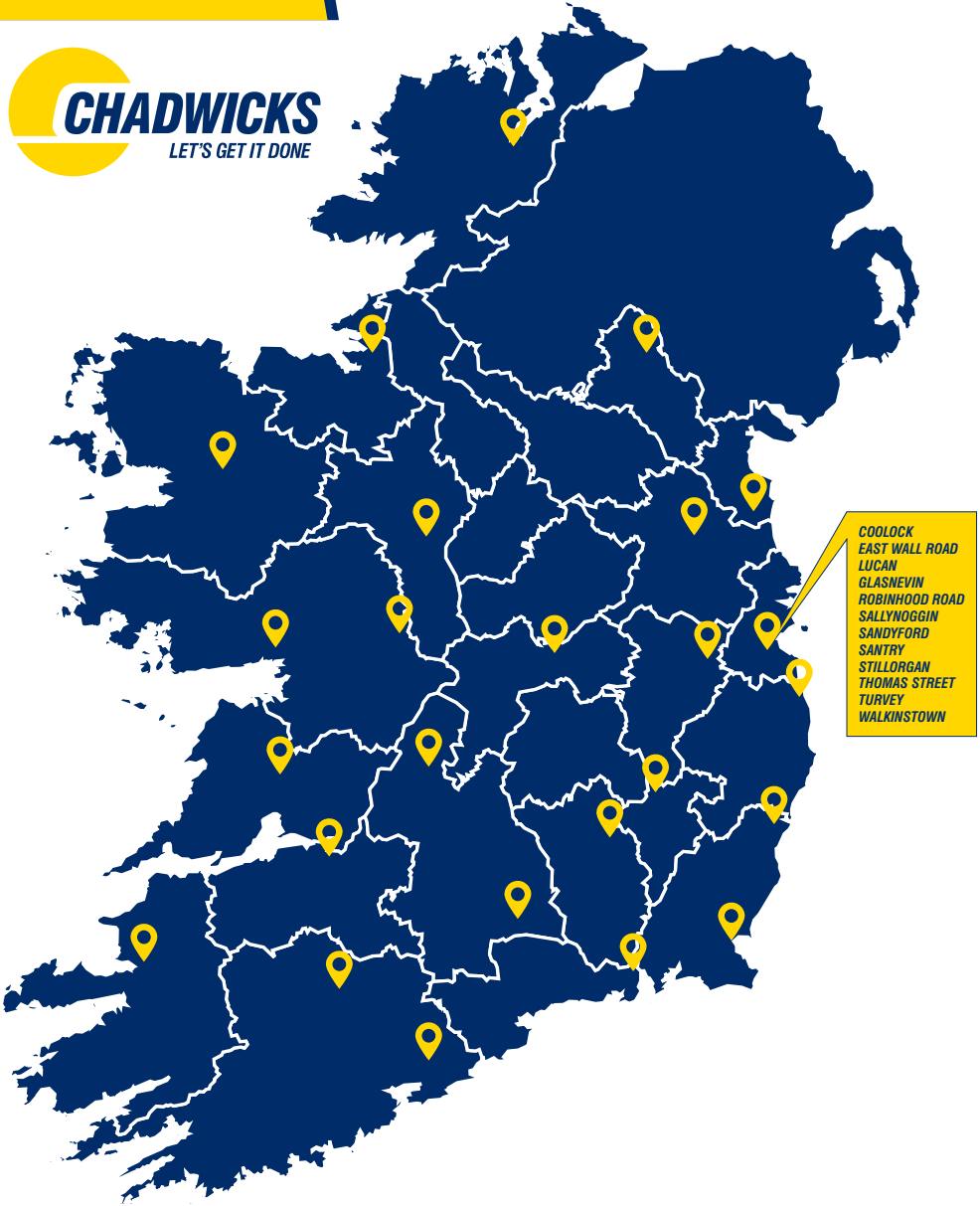

THE BIG CASH TRADE CARD TERMS AND CONDITIONS

1. The Big Cash Trade Card is a customer programme under which all existing and potential customers of the Chadwicks Group t/a Chadwicks, Heiton Buckley, Panelling Centre, Cork Builders Providers Ltd, Telfords Portlaoise Ltd and Davies Ltd (hereinafter called "The Company") can avail of.
2. Customer Data is collected using the Big Cash Trade Card Application form for the purpose of setting up and maintaining the Big Cash Trade Card Account. When completing the application form customers will have the choice to 'Opt In' to receive information from the Company about our products and services which could include discounts and events at your local branch, new products and updates to our ranges, hospitality invites, new or extended services and promotions such as rewards schemes. There is no requirement to 'Opt In' for marketing information in order to open a Big Cash Trade Card account.
3. If a customer no longer wants to receive Marketing correspondence etc, when they inform the Company, they will be removed from all correspondence lists.
4. Customer data will be deleted from the Companys ERP system, in line with the Companys Data Retention Policy.
5. The Company reserves the right to alter or amend these terms and conditions without prior notice at any time or to introduce supplementary or additional terms and conditions.
6. A FOB will be issued to each customer once the application form is completed. All FOB's issued remain the property of the Company. No customer data is stored on the FOB.
7. The Company reserves the right at any time without prior notice to amend, withdraw or terminate the Big Cash Trade Card programme and or the FOB.
8. The Company reserves the right to deny entry to the Big Cash Trade Card programme to anyone who holds an account or accounts with any subsidiary of Grafton Group Plc which is in arrears or in dispute.
9. The Company will not be prejudiced or restricted by any indulgence or forbearance extended to an applicant/customer. No waiver by the Company in respect of a breach of these terms and conditions shall operate as a waiver in respect of any subsequent breach of these terms and conditions.
10. Personal details that you provide to the Company or that the Company obtains through your use of the Big Cash Trade Card programme will be held by the Company in confidence and in compliance with all applicable legal and regulatory requirements relating to the obtaining, retention, processing and use (including use for marketing purposes, where the 'Opt In' for marketing has been completed by the customer) of personal data. No personal information will be divulged to anyone or any organisation except within the Company and third parties who process information on our behalf. The Company may use your personal details for the following purposes: To help manage the Big Cash Trade Card programme and improve the way the Company runs it; to help us understand our customers' shopping habits and preferences; to contact our customers in order to perform market research where consented to has been given and to perform profiling of shopper's behaviour in order to try and meet our customers' needs; and to improve the goods and services which we offer.
11. The Company may also use or share information relating to groups of applicants/customers, without identifying individuals, to enhance our understanding of customer behaviour and enable us to improve our service in general.

You have the right to request a copy of the information held by the Company about you, to have changed any inaccuracies in the details the Company holds about you, the right to object to the use of your data and the right to block any specific uses of your data, by means of a request by email to dataprotection@chadwicks.ie
13. All purchases through the Big Cash Trade Card programme are paid for by cash, debit card, credit card or bank transfer. The Big Cash Trade Card is not a credit facility and all goods must be paid for before receipt by the customer.
14. These terms and conditions are to be construed in accordance with the laws of Ireland and the parties submit themselves to the exclusive jurisdiction of the Irish Courts.
